Sub: Permission to commence the operations in the New Additional Liquid Berth LB03/04- reg.

The additional Liquid Cargo Jetty LB03/04 of M/s. JNPA, consisting of unloading platform of size 108m x 50m, mooring dolphins 04 Nos. & pump house 49m x 20m located at Jawaharlal Nehru Port, Village Nhava Sheva, Taluka Uran, Dist. Raigad, Maharashtra has been notified as Customs Area for unloading of Liquid Cargo under the provision of Section 10 & 8(b) of the Customs Act, 1962 vide Public Notice No. 87/2023-24 dated 05.10.2023. Further, M/s. JNPA has been appointed as the Custodian of the imported goods at the notified area under the provision of Section 45(1) and 141(2) of the Customs Act, 1962 and as a "Customs Cargo Service Provider", 1962 for the said area under Regulation 10 of the "Handling of Cargo in Customs Areas Regulations, 2009" vide Public Notice No. 15/2024 dated 23.02.2024.

In this regard, it is to inform that the Commissioner of Customs (NS-General), JNCH, Nhava Sheva has granted permission to M/s. Jawaharlal Nehru Port Authority for commencement of operation in the notified Customs Area as a Custodian of Import goods and for handling of such goods from the date of issue of this letter subject to compliance of all the provisions of the Customs Act, 1962 and the Rules, Regulations (including Handling of Cargo in Customs Area Regulations, 2009, as amended from time to time) and Notifications issued under the provisions of the Customs Act, 1962 from time to time.
