Facility Notice No. 05/2021

Sub.: - Facilitation for error free filing of E-manifests under SCMTR Regulation 2018 – reg.

Attention of all the Authorized Sea Carriers (ASC), Authorized Sea Agents (ASA), ATP (Authorized Transhipper), other entities/stakeholders and member of the Trade in the jurisdiction of Mumbai Zone-I, New Customs House, Ballard Estate, Mumbai, is invited to the Sea Cargo Manifest Transshipment Regulations 2018 (SCMTR 2018).

2. In this connection, it has been observed that despite numerous efforts wherein three webinars were conducted on 17.02.2021, 25.06.2021 and 12.08.2021 to guide the concerned entities and address the difficulties faced by them, the filing of e-manifests [SAM (Sea Arrival Manifest), SEI (Sea Entry Inwards), CSN (Cargo Summary Notification), SDM (Sea Departure Manifest) and SDN (Sea Departure Notification) and CIM-AR (Customs Inland Manifest-Arrival), CIM-DP (Customs Inland Manifest- Departure)] under SCMTR 2018 is significantly low due to repetitive errors resulting in faulty filing such as syntax error, date format error, invalid Transhipper code, invalid e-mail id etc. Most of these are common recurring errors and their resolution has already been compiled as 'Message Filing FAQ' and the same are available on the ICEGATE website. The same are also enclosed as Annexure A for ease of reference. Most of these errors can be avoided by going through the resolutions provided in the FAQs. Further, common repetitive errors resulting in faulty filing pertaining to Mumbai Port have also been compiled and model test files of various e-manifests are enclosed as Annexure B.

3. Though, the resolutions provided in Annexure A & B are sufficient for error free filing as most of the errors are recurring due to faulty filing and not related to systems, however, in order to further facilitate and ensure error free filing of e-manifests, all the ASC/ASA/Transhipper registered/operating under the jurisdiction of Mumbai Zone-I are allocated to Deputy/Assistant Commissioner of Customs (Facilitators) as mentioned in Annexure C to this Public notice.

4. The list of ASC/ASA/Transhipper who have not attempted to file e-manifests in new format under SCMTR is enclosed as Annexure D.

5. The roles and responsibilities of ASC/ASA/Transhipper and the Deputy/Assistant Commissioner of Customs are as mentioned below.

Role of ASA/ASC/Other stakeholders:

- a. All the allocated ASC/ASA/Transhipper shall be required to acquaint themselves with the common repetitive errors and their resolutions as mentioned in Annexure A & B, and shall be required to test file the e-manifests and intimate the concerned Deputy/Assistant Commissioner of Customs about the success/failure of such filings and difficulties faced if any before the arrival of the vessel.
- b. All the allocated ASC/ASA/Transhipper shall be required to intimate the concerned Deputy/Assistant Commissioner of Customs about the arrival of the vessel, 7 days in advance or after generation of VCN (Voyage Call Number) whichever is earlier.
- c. All the allocated ASC/ASA/Transhipper shall be required to file e-manifests as per timeline prescribed under SCMTR Regulation 2018 and shall intimate the status of the filing to the concerned Deputy/Assistant Commissioner of Customs.
- d. All the allocated ASC/ASA/Transhipper shall be required to approach the concerned Deputy/Assistant Commissioner of Customs, in case of any genuine difficulty faced with errors related to system, if any, for further escalation with DG Systems.


Role of Deputy/Assistant Commissioner of Customs:

- a. The Deputy/Assistant Commissioner of Customs will compare the details of VCN number generated from ICEGATE with the advance intimation of arrival of vessel submitted by ASC/ASA/Transhipper.
- b. The Deputy/Assistant Commissioner of Customs will also ensure that ASC/ASA/Transhipper mentioned in Annexure D, the ones not attempting to file e-manifests, shall file the same.
- c. The Deputy/Assistant Commissioner of Customs will ensure that all the allotted ASC/ASA/Transhipper under them are filing error

free e-manifests by avoiding common repetitive errors as mentioned in Annexure A & B, as per prescribed time limit.

- d. The Deputy/Assistant Commissioner of Customs will escalate the system related errors that are not resolved locally in filing e-manifests to Deputy Director, DG Systems under intimation to SCMTR helpdesk.
- e. The Deputy/Assistant Commissioner of Customs will submit a fortnightly progress report, as per Annexure E to this Public Notice, to the Additional Commissioner of Customs (EDI) in this regard on email id: scmtr.nchmumbai@gov.in

6. Any difficulty faced in the implementation of this Public Notice may be brought to the notice of the undersigned. This facility notice shall also be treated as Standing Order for the purpose of officers and staff.

Message Filing FAQs

I. SEA MESSAGES

1. Why have I not received the acknowledgement (ACK)?

This could happen due to various reasons.

- a. Please ensure that the file is named following the naming convention and schema as given in the Message Implementation Guide (MIG).

Expected pattern:

(<messageType>_<msgID>_<reportingEvent>_<SenderId>_<jobID>_<date>_DECSigned.json)

Example: F_SACHM23_SAM_ICEGATEID_7031_20210101_DECSigned.json is the naming to be adhered to for SAM.

- b. Please ensure that the SenderID is the actual registered ICEGATE ID of the entity.
- c. The Sender should be registered at ICEGATE and should have an ICEGATE ID.
- d. Please use the DSC used at the time of registering at ICEGATE to sign the json file.
- e. Please make sure that the correct utility is used for signing the json file. The utility meant for signing json files is also available for use at the ICEGATE Website.
- f. Please do not open the file after the file has been signed.
- g. Please send the file from the same computer from which the file is signed.
- h. If there is an error in your file, please open a fresh file, make the required correction, digitally sign the file and send without opening.

Having ensured all the above, the ACK file shall be emailed to the registered email associated with the ICEGATE ID.

1. I am getting errors like "Invalid Entity Code", "Invalid Authorized Person Code", "Invalid Mode of Transport", "Invalid Transport Means", "Invalid Transport Means Identity", "Invalid Voyage Call Number" all at the same time. What correction should I make?

The above errors are mainly due to the Voyage Call Number (VCN) mismatch. Make sure that you have inserted the correct VCN. PCS receives VCNs in different formats from multiple ports, which at Customs have been standardized.

Format: Location Code (6 chars) + Year (4 digits) + 4 digits running serial no.

Ex. For Nhava Sheva for 2021 - INNSA12021XXXX will be the VCN number format.

2. I have entered the correct CSN Number and given CSN in the "mcinpcin" field in the previous declaration object. But I am getting error. Why?

When you are entering the CSN number, please enter the "csn" in the "cinTyp" field. Enter pcin or mcin as the case maybe , in the "mcinpcin" field when you are entering pcin number or mcin number.

3. The ACK I received shows all objects as "successful" but the email shows that the file failed. Why?

It is possible that while creating the message, a required object was not included by you in the json file. The error for the missing fields will still get generated. It will not show in the ACK as the object in your file does not exist. Please report such instances to icegatethelpdesk@icegate.gov.in for resolution.

II. INLAND MESSAGES

1. Why am I getting "Mismatch of sb details in CIN and transhipper" error?

Please ensure that you have inserted the correct SB.No., Date & Site.

2. Why am I getting "Cargo is not available at reporting site for stuffing" error?

This is due to location code mismatch. Please ensure that you have inserted the right site ID.

3. I am getting the error "SB is not ready for stuffing". Why?

The current current queue is not set at stuffed.

4. I am getting the error "Pkg no & kind mismatch". Why?

The package quantity and /or kind is not matching

1. Successful sample files for filing SAM/SEI/SDM are attached to this public notice as Annexure B. Further, filing of SDM with cargo & SDN filing are under technical resolution and will be rectified soon.

3. For errors pertaining to File Format of SAM, it should be ensured that the format is in the following form:

F_SACHM23_SAM_ICEGATEID_7031_20210101_DECSigned.json
SEI File - F_SACHM23_SEI_ICEGATEID_7031_20210101_DECSigned.json
SDM File - F_SACHM23_SDm_ICEGATEID_7031_20210101_DECSigned.json

4. For errors related to Digital Signatures, it should be ensured that Digital signature has to be done with generation of . json file extension & not with generation of .igm file or .egm file extension.
5. Inside SAM .json file master, filling of “vesselTypMvmt” is to be done as mentioned below:
If last port of the vessel is Indian, it will be coded as – II
If last port of the vessel is Foreign, it will be coded as – FI
6. For filing of Nil SAM in “voyageDtls” the following description is to be mentioned:
“totalNoofTrnsprtEqmtMnfsted” – 1
“totalNmbrOfLines” - 0
7. The ETA (Estimated Time of Arrival) / ETD (Estimated Time of Departure) timings have to be exactly the same as declared in PCS (Port Community System) with date format as YYYYMMDD.
8. In case of validation errors, the following steps are to be followed:
 - Once .json file extension is created & signed avoid opening it
 - The .json signed file should be submitted from same desktop where downloaded & signed
 - in case validation error you may check on link & recheck your file with below link <https://jsonformatter.curiousconcept.com>
9. In case of Response Delays, the following are to be checked:
 - File should be emailed from the ICEGATE registered email Id only.
 - Please check for errors in the generated file.
 - Job number should be changed as every file has its own unique job number given by the submitter.
10. Model test files for the following e-manifests are enclosed:
 - i. SAM Sample file with Cargo,
 - ii. SAM Sample file with Nil Cargo,
 - iii. SDM Sample file with Nil Cargo,
 - iv. SEI Sample file with Cargo,
