CIRCULAR

In partial supersession of the Circular No. TF/SH/Berthing Policy/Corresp/2019-II/6801 dated 28/07/2022, the following amendments have been made to the Berthing Policy.

(A) The following clause is being introduced in the 'General Instructions' section:

"In case a vessel fails to commence cargo operation within 4 hours from the Time of all fast, the vessel will be liable to be shifted to OTB in the next immediate suitable tide at the cost and responsibility of concerned vessel agent. The vessel, in such case, however will be allowed to continue work till shifting subject to payment of 3 times additional penal berth hire charges. In case there is no taker for the berth the vessel will be permitted to continue till completion of cargo under three times additional berth hire charges till the vessel vacates the berth."

(B) Appendix-01B of the Berthing Policy stands modified as follows:

Notes:

- A) Priority Berth Hire charges as per the applicable SoR will be levied for berthing LPG ships in OJ-1 ahead of any other ship eligible to be handled in OJ-1.
- B) The senior most edible/ vegetable oil tanker will be berthed at OJ-7 subject to availability of the jetty. In case the jetty is occupied/ otherwise not available, the ship will be considered for berthing at in OJ-1 to OJ-4.
- C) The number of Edible Oil tankers to be berthed at Oil Jetty No.1 to 4 will be restricted to two, subject to they are being senior to non-edible liquid tankers. There will be no restriction on berthing of non-edible liquid tankers. In case if no tanker is waiting and tankers are allotted berth on ETA basis, the restriction of two Edible Oil tankers at Oil Jetty No.1 to 4 will apply if there is no non-edible oil tanker waiting for berth or expected to arrive before tide.
