Accordingly, all importers and exporters are issuing QR based HEP from their respective registered ID through Paradip Port Trust website and since then the system the QR based HEP is being is running successfully. However, issued by respective parties, the Port Trust is unable to get any information regarding the Transit Pass (T.P) which is being issued by Department of Steel & Mines, Govt. of Odisha after loading of the trucks. This is an important document based on which, PPT files the return of receipt in the i-3MS portal of Steel & Mines Department, Govt. of Odisha.

Hence, it is requested that all exporters of minerals shall provide the detail information of the Transit Pass (T.P) in the following format on the next day after unloading of the trucks, in order to file the return in the aforesaid website.
