Sub: Major Port Authorities Act, 2021-Constitution of Implementation Committee.

The Major Port Authorities Act, 2021 has been notified by the Ministry of Law & Justice (Legislative Department) on 18th February, 2021.

- 2. The Indian Ports Association, by letter dated 24.2.2021 has forwarded a copy of Major Port Authorities Act, 2021 and has informed that as per the provisions for the Act, the Board of Major Port Authority in respect of each Major Port is required to frame Regulations on various items as mentioned in Section 72 and to take necessary action as may be required under other provisions in the MPA Act.
- 3. The IPA has also informed that as per Section 1(2) of the Act, the Ministry is required to appoint a date by a notification in the official Gazette when the MPA Act shall come into force.
- 4. By letter No.GAD/G/REG/1031 dated 3.3.2021, the IPA has been informed that in terms of Section 3(1) of the MPA Act,
 - "3.(1) The Central Government shall, within a period of ninety days from the date of commencement of this Act, by notification, in respect of each Major Port, constitute a Board called the Board of Major Port Authority for the Major Port.......

Further, as per the proviso to Section 3(1) that "until the constitution of the Board of Major Port Authority, the Board of Trustees constituted under Section3 of the Major Port Trusts Act, 1963 shall continue to function and shall cease to exist immediately after the constitution of the Board under the MPA Act, 2021"

Further, it has been informed that framing of new Regulations under MPA Act is under process. Efforts will be taken to examine and frame the

Rules/Regulations under MPA Act, 2021 at the earliest. The IPA has also been informed that Shri P.H. Salvi, Dy. Chief Law Officer has been nominated as the Nodal Officer for this purpose.

5. In view of the above, the Chairman by orders dated 14.5.2021 has accorded approval to constitute a Committee of following officers to ascertain the role of MbPT for smooth transition from MPT Act, 1963 to new Act, i.e. MPA Act, 2021:

Dy. Chairman

- Chairman of the Committee

Traffic Manager

FA&CAO

Harbour Master

Dy. Chief Law Officer - Convenor of the Committee meetings.

Dy. Secretary (HR)

Dy. Secretary (GAD)

While according approval to the constitution of the Committee, the Chairman has minuted as under-

"Proposal is approved and the Committee should submit its report in 20 days."

- 6. The Committee will study and ascertain the role of MbPT for smooth transition from MPT Act, 1963 to new Act, i.e., MPA Act, 2020. In this context, the Committee may seek necessary inputs from other Ports, if need be.
- 7. The Committee will submit the Report to the Chairman.
