## Subject: Amendment in Tariff structure

Dear Sirs,

Mundra Port has always been a trusted partner to all stakeholders and we value the deep-rooted partnership with all valued clients. The Port on regular basis keeps on reviewing and revisiting the tariff structure on yearly basis.

The revised charges shall be applicable for all the vessels arriving at Mundra on or after 0001 Hrs. of 15<sup>st</sup> October 2021.
