
**Sub: Registration of unorganized Dock Workers on e-SHRAM portal.**

Ministry of Labour & Employment, Government of India, is continuously working on improving life and dignity of Labour force of country by protecting & safeguarding the interest of workers, promotion of welfare and providing social security to the Labour force both in Organised and Unorganised Sectors by enactment and implementation of various Labour Laws, which regulate the terms and conditions of service and employment of workers.

2. Ministry of Labour & Employment has developed e-SHRAM portal for creating a National Database of Unorganised Workers (NDUW), which will be seeded with Aadhaar. It will have details of name, occupation, address, educational qualification' skill types, family details, bank details etc for optimum realization of their employability and extend the benefits of the social security schemes to them. It is the first-ever national database of unorganised workers including migrant workers' construction workers, gig and platform workers' etc.
3. Registration of such workers can be done individually or with the help of Common Service Centre (CSC). Address of e-SHRAM portal is :<https://eshram.gov.in>
4. All the port users are requested to register all such workers who are falling under the category of unorganized workers, through the facility available at e-SHRAM portal or with the help of Common Service Centres (CSCs) in Mumbai, details of which are available on e-SHRAM portal.
5. Details of such day to day registration i.e Name of the worker, their Universal Account No. (UAN) and date of registration may kindly be informed to Dock Entry Permit Section on daily basis on e-mail address:- [dep.mbpt@mumbaiport.gov.in](mailto:dep.mbpt@mumbaiport.gov.in).
6. You are requested to give wide publicity in this regard amongst your members.
