
During the discussion with concerned stake holders involved in export of cars, few issues were highlighted by the car exporters and the same was taken up by Administration and it has been decided as under -

- (a) Issuance of VDS for the Car carrier vehicles to be discontinued with immediate effect.

(b) The vehicle entry permits issued at the dock "in gates" for Trucks, Trailers, Car carrier vehicles shall be valid from the "shift of entry plus two subsequent shifts".

2. All concerned are requested to take note of the above and if any difficulty faced in the implementation may be brought to the notice of Dy. Traffic Manager, Cargo Accountal or Sr. Dy. Traffic Manager, Operation-Docks.
