- 1. Whereas Bunker Supplier's as per list in show cause notice are registered with Directorate General of Shipping holding valid Bunker Supplier Registration Certificates
- 2. Whereas show cause notice no 13-22/17/2020-ENGG-DGS dated 21.12.2020 was issued to the companies who had violated statutory provision's as per para-4 and directed to reply for their failure to comply statutory provision's.
- **3.** Whereas letter no 13-22/17/2020-ENGG-DGS dated 04-02-2021 was issued to the companies who had violated statutory provision's as per para -4 and were directed to comply the para 8.4 of MSN 3 of 2014 within 15 days from date of issuance.
- 4. Whereas Para 8.4 of MS Notice 3 of 2014 is quoted as below,

"Certificate issued as above shall cease to be valid, if the Bunker Supplier fails to carry out an annual surveillance audit within three months, before or after each anniversary date. The verification report has to be forwarded to the Directorate, on completion of the audit for records".

- 5. The above provisions was provided so that the companies could have acted proactively to comply statutory provision, However the companies has failed to do so and hence the competent authority has decided to withdraw the bunker registration certificates of the companies as per attached list Annexure-I.
- 6. This letter is issued with the approval of competent authority.
